Course Description:

This course will introduce you to qualitative methodology as it is theorized and applied in social sciences and cultural studies. Starting with philosophical and paradigmatic foundations, you will learn about ethnography (including feminist ethnography and auto-ethnography), discourse analysis, and grounded theory, especially from postmodern and poststructural perspectives, and gain hands on experience on research design, data collection, data analysis and writing, including creative, alternative ways of academic writing.

Course Objectives:

By the end of this course, I would like you to:

- gain an understanding of the various traditions of qualitative methods with their philosophical/ theoretical and historical origins, development and strategies,
- gain experience in research design, data collection (especially interviewing), data analysis, and academic writing
- gain exposure to traditional and alternative (postmodern, poststructural, auto-ethnographic) writing styles in qualitative research
- be able to critically assess research reported by others found in academic, policy, and media sources

Course policies:

Your grade in the class will be determined by:

- Term Paper:
 - March 14: Formulation of the research question (5 pts). Bring it class, we will work on them.
 - March 28: Introduction and a short Literature review due (10 pts).
 - April 11: Methods section and revised versions of Intro and Lit review due (methods includes choice of method and research instrument e.g. interview form, observation protocol, etc.) Read ahead for discourse analysis, if you will use that as your analysis method (20 pts)
 - May 16: Data Analysis and Research Memos due (please attach your data –transcripts, observations, archival data/documents etc.) (15 pts)
 - June 2: Final Paper (50 pts).

Term Paper: Using Prof. Dayi's research study entitled "Transnational politics of reproduction: A comparative study of Turkey, France, and the United States" as a framework, each student will formulate a research question of their own interest and conduct a small scale research using ethnographic methods such as in-depth interviewing and analysis of archival data (e.g. analyzing media news, reports, policy reports, medical curriculum, etc.) and write a research paper on it.
